QUEEN PAGEANT RULES

The purpose of the Morgan County Fair Queen Contest is to promote our community and leadership in the young women of our community.

Participants must meet the following recommendations, rules and guidelines:

1. Participants in the Queen Pageant shall not be less than eighteen (18) nor more than twenty-two (22) years old on June 1, 2022. Entrant must attach either a copy of her birth certificate or driver's license as proof of age to the application.
2. Participants in the Princess category must adhere to the same rules listed below. Princess participants shall not be less than fourteen (14) nor more than eighteen (18) years old on June 1, 2022.
3. Participant must currently reside in Morgan County and must present proof of residency.
4. Participant must be single, never married, have no children and must not be pregnant at the time of the contest or during her reign if crowned queen.
5. Any contestant who has competed or participated in a prior Indiana State Fair Queen Pageant cannot compete or participate again.
6. Any contestant who has previously been awarded the title of Miss Morgan County Fair Queen cannot compete or participate again.
7. The use of drugs or alcohol during the pageant, fair, or any other representative duties by any participant will not be tolerated and will result in immediate dismissal from the pageant.
8. All participants must attend a dress rehearsal with the pageant coordinators on Friday, June 13, 2022 Location TBA
9. The queen and her court must participate in various activities throughout the 2022 Morgan County Fair and may be invited to participate in non-fair related activities in the community during her reign.
10. In the event of a tie, the highest score from the interview portion will be used. If another tiebreaker is needed, the queen will be chosen by a judge's/director's group decision.
11. The winning entrant is required to attend and compete in the Indiana State Fair Queen Pageant in Indianapolis, Indiana, held in January 2023.

12. Participants should give thoughtful consideration to their use of social media and be advised the Morgan County Fair Queen Pageant reviews all participants' internet presence for appropriate behavior.
13. In the event the winning entrant is not able to fulfill her duties as the 2022 Morgan County Fair Queen, the contestant named First Runner Up will assume the title of the 2022 Morgan County Fair Queen.
14. A \$35.00 entry fee is applicable for each Participant and must be submitted with the Participant's application.
15. Queen contest will be held on June 11, 2022. Orientation will be May 20th , Location TBA
